

## Information notice pursuant to Art. 13 of Legislative Decree n. 196/2003

Dear Sirs,

in compliance with the personal data protection Code, enacted in Italy by Legislative Decree no. 196 of 30 June 2003 (hereinafter the “**Privacy Code**”), and with respect to the personal data which may become available to *Studio Legale Associato Simonetti Persico Scivoletto* (hereinafter the “**Firm**”), please note as follows.

**1. Subject-matter and purposes of data processing.** Following your request of professional services to the Firm and/or by entering the Firm’s website, your personal data may become available to the Firm, directly or via third parties. Without prejudice to the rules governing professional confidentiality, all personal data will be collected and processed in full compliance with the Privacy Code and will be handled only in order to fully and properly (a) carry out the professional activities requested, be them of a judicial or extrajudicial nature, (b) perform the obligations arising under a contract between you and the Firm and (c) inform you – by mail, fax or e-mail - of the activities, ventures and services carried out by the Firm. Failing your communication of personal data, the Firm may not be in the position to accomplish, in whole or in part, your professional requests, or could resolve any outstanding contractual relation.

**2. Processing arrangements.** Your personal data will be processed both manually and through computer equipment and will be stored at the Firm’s offices, or at other appropriate premises. Your personal data will be kept for the time period required to achieve the purposes set forth in point 1. above, and subsequently for the time period prescribed by the legislation in force, for accounting and/or tax purposes.

**3. Scope of application.** Your personal data may be communicated to the persons in charge of processing them, and also - for purposes indicated under point 1 above - to those third parties (e.g.: external counsels, counterparts and their lawyers, arbitrators, etc.) who may need to receive them in order to properly accomplish the activities set forth under point 1. above.

**4. Cross-border data flows.** Your personal data may be transferred to other EU and non-EU countries, within the frame of the purposes set forth under point 1. above.

**5. Rights of the party concerned.** According to Art. 7 of Privacy Code, the party concerned has the right to (i) obtain confirmation as to whether or not personal data concerning him/her are available, and obtain communication of such data in an intelligible form; (ii) be informed of the source of personal data, the purposes and methods of their processing, the logic applied to their processing, the references of the Data Controller as well as of other persons to whom the personal data may be communicated; (iii) obtain updating, rectification and integration of data, erasure, anonymization or blocking of data which have been processed unlawfully; (iv) object, on legitimate grounds, to the processing of personal data.

**6. Data Controller.** Data Controller is *Studio Legale Associato Simonetti Persico Scivoletto*, with registered office in Rome, via Antonio Bertoloni 19.
